4. **\$70.00 w/o IFL Card or \$60.00 with IFL Card**- cash, debit/credit or check made payable to Fullerton Union High School (lost or stolen permits may be replaced for \$35.00).
5. Clear of all fines (\_\_\_\_) and sufficient credits. Juniors = 110 credits & Seniors = 165 credits

**PLEASE READ AND SIGN:**

1. A permit does not guarantee a parking space. No refunds will be issued in the event that there is little/no parking.
2. Parking is first come, first served.
3. This permit is non-transferable to another student.
4. The police may issue citations for improper parking, improper display of permit, and all other motor vehicle violations.
5. Parking illegally may result in towing of the vehicle from the parking lot at my expense.
6. I may be in the parking lot only when arriving at or leaving school. Any other time requires written permission from the school office.
7. I will not move my vehicle from one parking lot to another during school hours.
8. I will only park my vehicle during school hours in the appropriate school parking lots (Lemon and Farm) and never in the stadium, STAFF designated spots, or handicap accessible spots.
9. I understand that if I park in any adjacent private business property, I will not leave campus during school hours and go to my vehicle.
10. Supplying false information on this application will result in revoking of this permit and loss of my parking privileges.
11. This permit may be revoked by the school administration for violation of these guidelines and/or vehicle code violations on campus.
12. The speed limit on school grounds is 10 mph.
13. Students using the parking lot do so at their own risk. Neither Fullerton Union High School nor the Fullerton Joint Union High School District assumes any liability for theft or damage.

## FULLERTON UNION HIGH SCHOOL TERMS AND CONDITIONS

**By signing this application for a student parking permit, I acknowledge that:**

1. I have received a copy of school parking regulations, and I understand and will obey the regulations.
2. I now have and will continue to maintain a valid driver's license and vehicle liability insurance in accordance with California law.
3. As a condition of being allowed to bring a vehicle to school and park on school property, I understand that district staff may inspect and search my vehicle whenever it is on school property.
4. Applicant agrees to indemnify, defend, and hold harmless the Fullerton Joint Union High School District, its agents, officers, and employees from and against any and all liability, expense, including defense costs and legal fees, and claims for damages including, but not limited to, bodily injury, death, personal injury, or property damage arising from or connected with student vehicle operation, including liability, suits or expense arising from or connected with student vehicle use and parking on school site.
5. I understand that parking on Fullerton Joint Union High School District property is a privilege which may be revoked if I choose to disobey the parking regulations and student behavior standards.

### AUTOMOBILE SEARCH POLICY

Since schools are not completely public buildings, their parking lots are subject to the same safety-related rules to which the buildings can be subjected. A policy authorizing search of automobiles choosing to use the school parking facility, whether or not those automobiles are student owned, may be adopted. The policy will then apply to students, teachers, and visitors alike.

### VEHICLES SUBJECT TO SEARCH

Any vehicle entering this area is subject to search at the direction of school authorities. Search may be conducted without warrant for any reasonable purpose. Search of the vehicle includes all compartments and components thereof. Once notified of intent to search, the person in control of the vehicle will not be permitted to remove it from the premises until the search is completed.
