



In light of developments in the debate over a ban of the social media platform TikTok, the Orange County Board of Supervisors voted March 14 to approve a proposal that will ban the app from all county government-issued devices.

Launched in 2016, the app’s user count grew significantly to over one billion active users with more than 100 million in the U.S. As the app’s popularity increased, so have the concerns of security experts. Much of this unease stems from the possibility of the Chinese government employing user data to track location and browsing history to potentially drive misinformation efforts.

The ongoing discussion over the future of TikTok escalated after the Biden Administration threatened to impose a ban unless the app’s Chinese parent company ByteDance divests itself from the platform. The ultimatum presented by the U.S. Committee on Foreign Investment marks a new climax in negotiations between federal officials and the company’s Beijing-headquartered owner.

Largely led by Republican lawmakers in Congress, the push to ban TikTok resulted in an initial smaller-scale ban of the app from government-issued devices. This removal will block any attempts to access sensitive data from federal employees privy to classified information, Texas Representative Michael McCaul said in an interview with Time Magazine.

“Anyone with TikTok downloaded on their device has given the CCP a backdoor to all their personal information—it is a spy balloon into their phone,” McCaul said. “It is too dangerous [for the app] to be on our phones as members of Congress [or] our children’s phones. That is

the whole point of this bill.”

Throughout the drafting of this proposal, the company remained adamant that the demand for major Chinese stock owners to sell to Americans as a transfer of influence over TikTok will not effectively address security concerns. Rather than resorting to extreme measures, such as a universal ban or divestment, more emphasis should be placed on transparency and strengthening of safety measures, a TikTok spokesperson told Time Magazine.

“If protecting national security is the objective, divestment does not solve the problem: a change in ownership would not impose any new restrictions on data flows or access,” the spokesperson said. “The best way to address concerns about national security is with the transparent, U.S.-based protection of U.S. user data and systems, with robust third-party monitoring, vetting, and verification, which we are already implementing.”

With political pressure mounting, TikTok CEO Shou Zi Chew testified March 23 on Capitol Hill, where lawmakers confronted him over the threats to security his app poses. Amid uncertainty over the app’s future, TikTok users began sharing both honest and satirical grievances, counting the days until one of their main sources of entertainment, social media-based income, sponsorships and publicity disappears.

Although the materialization of such dramatizations may remain far in the future for now, experts suggest users should take this time to review privacy settings and make sure they feel comfortable with the impact TikTok has on their lives.

Fullerton College invites students to 12th annual French Film Festival

The festival immersed Orange County citizens in French culture through festivities, art and cinema.

Providing an immersive experience in French language and culture, Fullerton College hosted its 12th annual French Film Festival March 27-29 for college and high school French learners.

Sponsored by the Humanities Division, the festival engaged students with various aspects of French culture including music, food, art and games. Festival attendees enjoyed jazz interludes and a choir performance, along with a variety of food from local vendors including Crepes Bonaparte. Participants also played Joue A La Pétanque, a French game similar to the game "bocce" in which players attempt to roll a ball closest to a given target on the ground, typically marked by a smaller ball.

An hour into the festival, attendees were brought to the campus theater to watch a French film with English

subtitles to follow along. Each day of the three-day festival featured a different film open to the entire community. The first day of the festival showcased "Blackbox," a suspenseful drama which tells a mystery about a motor black box analyst who utilizes his expertise in sound engineering to investigate the cause of a deadly airplane crash.

According to Warrior French teacher Will Fritz, the benefits of exposure to visual and audio media for language learning transcends the film festival. These films also broaden student horizons beyond language learning, Fritz said.

"I thought it was interesting to see an aspect of the aviation industry [in 'Blackbox']," Fritz said. "We do not [usually] think about a career as specific as someone who sits there, listens to the recording and really analyzes the sound down to the level of the hertz and the megahertz."

With various genres to choose from, the audience decided on the passionate romance film 'Eiffel,' in which French engineer Gustave Eiffel's long-lost love inspires the Eiffel Tower design

under the intense pressure of Paris' upcoming World Fair. The last night of the festival, designated as High School Night, screened "Hawa," a coming-of-age story of a young girl who attempts to meet and convince Michelle Obama to adopt her.

According to the French professor Catherine Reinhardt-Zacair, the festival requires 12 months of planning beginning

with choosing three films from a selection of about 50 films. With planning led by a collaborative effort across the college, the stage manager and opera professor helped organize the singing, while the campus French club created games and painted various backdrops for the attendees. In addition, the administrative staff handled the tents, lights and set-up.

"Students in high school can see the culture they are learning in action and Fullerton College students are deeply involved in the planning process," Reinhardt-Zacair said. "My favorite part about the festival is being [there] when everybody is enjoying the celebration and hanging out with friends and meeting new people. It is a gathering time and place around culture."

Known for his dad jokes and passion for teaching AP and IB Biology, Warrior teacher James Kirkpatrick received the 2022-2023 District Teacher of the Year Award Feb. 8 and is currently competing for the Orange County Department of Education Teacher of the Year Award. From a young age, Kirkpatrick knew he had a passion for helping others. After a brief stint working as an operating room technician, Kirkpatrick realized that he wanted to pursue teaching. The philosophy of making a positive difference in a young person’s

life remains one of Kirkpatrick’s current, key mindsets towards life fulfillment. Although he teaches the same subject every year, Kirkpatrick claims that the diversity of students he meets continues to spur his passion for teaching. “I love the different classes I get and the variety of students I get every year,” Kirkpatrick said. “The different students I get each year make it interesting since they arrive in my class with different questions, expectations, interests and passions. Being able to answer each question and pique a student’s interest in any field of biology excites me.” To become eligible to receive the District Teacher of the Year Award, colleagues of a candidate must vote for them. The district then named Kirkpatrick as one of the nominees to compete for the OCDE Teacher of the Year

As anyone with a pet of their own can attest, these little creatures carry a rejuvenating energy everywhere they go, brightening days and soothing anxiety. Now is a great time to adopt a fur baby of your own because April 30 is National Adopt a Shelter Pet Day!

Rescues, shelters and pet cafés like OC Animal Care and Crumbs and Whiskers are some accessible places to find the newest member of your family. Those interested in adopting can visit the OC Animal Care website to view all available pets—dogs, cats, rabbits, birds and more—and call the shelter to schedule a time to bond with a prospective pet. Once pets and parents choose each other, only a

quick trip to the adoption desk is needed before heading home together. Even in the excitement of adoption, it is essential to make the commitment only after understanding how much change that bringing a new life into your home will require.

While local shelters do all that they can, a lack of space still threatens animals with euthanasia. Perhaps nobody at Troy understands the harm of puppy breeders more than the President of the People 4 Animal Welfare Society Liam Jones. “Breeders are not obligated to spay or neuter when they sell animals...as a result, many of these animals end up in high kill shelters,” Jones said. Breeders’ “pure-bred” pets are also notoriously more expensive than shelters’, pocketing money that could have been used to feed in-need animals. These issues are not

applicable at shelters, which responsibly care for their animals, including pure-breds. Unfortunately, many have the wrong impression of shelter pets, dismissing them as rabid simply because they have yet to find homes. Inaccurate associations with beasts behind metal bars can pollute the idea of shelter pets. Though behavioral quirks can manifest in mistreated animals, a majority are simply sweet companions in need of homes.

National Adopt a Shelter Pet Day is the perfect reason that these pets have a warm bed and a loving family. So, this April 30, venture out to the nearest shelter and find the newest (and most likely furriest) member of your family!







Americans must understand that the Willow Project is not black and white

The Willow Project is a vital and necessary evil for America's future.

On March 13, President Joe Biden and his administration approved energy company ConocoPhillips' Willow Project, a highly controversial, large-scale oil drilling plan set in Alaska. The project will build three oil pads in the Alaskan North Slope and collect around 600 million barrels of oil in 30 years. After approving the plan, Biden faced a massive wave of warranted backlash from climate change activists and Native Alaskans due to its proximity to indigenous land and neighborhoods. However, the extent of this backlash has gone too far.

Though the approval of oil drilling in Northern Alaska poses many threats to surrounding nature, the American populace must understand the potential financial problems that will follow if the project is canceled. According to CNN, the courts cannot legally nullify the Willow Project since ConocoPhillips had already prepared the land for the project under the Trump administration. Forcing the company to rescind its prior arrangements would result in heavy

finances and legal actions, such as a possible five-billion-dollar lawsuit. Regardless, popular websites and social media accounts such as change.org spread a narrative that makes stopping the project look much more black and white than it actually is. With many people falsely believing that cutting the project would have no financial repercussions, the entirety of the

Willow Project should be projected to a broader audience. Activists must also recognize the changes and amendments that were made to lessen the harmful effects of the initial project. The Alaska Public Media reported the initial approval of the Willow Project from the Trump administration, which would begin with three drilling pads and extend to five drilling pads later in the process. Since then, more climate conscious changes, such as decreasing the project's size, were made to retain its economic benefits while lowering its ecological footprint as much as possible. The shortened number of oil pads lessens the project's acreage, causing less damage to the surrounding land and minimizing the amount of oil produced from the Alaskan North Slope area. This is not to say that there will be no harmful emissions, but compared to the initial project approved under President Trump, a small change is better than none. Additionally, the project is crucial for the Alaskan economy. The Willow Project is set to create 2,500 construction jobs and 300 permanent ones, employing a quarter of

the Alaskan North Slope area. With many areas of Alaska still depressed by the COVID-19 shutdown, this massive wave of new jobs is vital for many communities. Fox Business reported that the project is meant to produce between 8 billion and 17 billion dollars in revenue on a federal, state and local level. The stream of revenue from the project will also allow many indigenous communities more financial independence versus reliance on government aid. Keeping risky older drivers off the roads demonstrates the potential to save lives

Driver safety laws prevent unnecessary injuries and fatalities.

Actor Dick Van Dyke, famous for his roles in movies such as “Mary Poppins” and “Chitty Chitty Bang Bang,” was left with minor injuries after a car accident on March 22. Because of this, the debate over whether older drivers should be allowed on the road has reemerged as a point of contention. A sizable number of elderly drivers have voiced their opposition to California law requiring those aged 70 years and older to take eye and knowledge exams. However, it is critical that laws that are designed to keep potentially dangerous elderly drivers off the road remain in place.

So-called “age discrimination” is not a valid argument against driver safety laws. Many elderly drivers claim that some driver safety laws target them, such as 75-year-old San Jose resident Suzanne Arnaud who told the Los Angeles Times that the law amounts to age discrimination. However, this argument fails to hold up when it is made evident that “age discrimination” is commonplace in our society. After all, the government does prohibit children from drinking alcohol or driving a car. Clearly,


enforcing laws based on age is common sense—as a society, we must acknowledge that age discrimination is logical.

Additionally, more incompetent older drivers on the road puts everyone at risk. According to Oxford Academic, “aging of the nervous system” impacts hand-eye coordination and reaction time, meaning that as you get older, it is more difficult to focus and remain coordinated, increasing the likelihood of a car accident. As such, it is important that older drivers demonstrate that they are cognitively capable so that they do not put others in danger.

While critics of elder-driving laws cite lower car crash numbers among older drivers compared to those aged 30 years old or younger, it is important to understand why that is.

The Los Angeles Times reports that drivers older than 70 represent roughly 10% of all licensed drivers in California, yet they were only involved in 7.2% of fatal crashes in 2019. On the other hand, drivers aged 20 to 24 years old made up about 8% of licensed drivers in California but were involved in 11.9% of fatal crashes. At first glance, it is a fact that younger drivers are more likely to be involved in an accident compared to older drivers. However, the reason for this is that younger drivers drive much

more. According to the U.S Department of Transportation, with an annual average of 15,098 miles compared to about 7,646, those who are younger drive nearly twice as much. As the data shows, it is safe to say older drivers are actually underrepresented in real crash statistics, and are responsible for more wrecks than they should be given the amount they drive. Ultimately, older drivers must

demonstrate that they can drive safely by participating in driver safety courses. This is necessary for a variety of reasons: age causes a decline in the sharpness of mental faculties and that a higher age corresponds to a higher crash fatality rate. At the end of the day, the facts paint a coherent picture: laws which prevent incompetent older drivers from gaining access to the wheel make our roads more safe.

Skittles consumers should “taste the rainbow,” not its numerous toxins

There should be no debate to ban toxins in our food.

On March 16, California lawmakers introduced Assembly Bill 418, which would ban five toxic additives found in many popular candies Skittles and Nerds. Many of these chemicals such as red dye No. 3 and titanium dioxide are linked to cancer and have been deemed unsafe for human consumption by other countries. If this bill is passed, foods containing the chemicals red dye No. 3, titanium dioxide, potassium bromate, brominated vegetable oil or propylparaben could be banned in California. While even the thought of losing these delicious candies is truly heartbreaking, this bill is a necessary advancement in prioritizing people’s health and safety over profit.

The regular use of these toxic additives poses a severe threat to American health. In 2016, Mars Incorporated was sued for their unsafe use of titanium dioxide in Skittles. Mars stated that the additive had no known risks to human

health and that the “use of titanium dioxide complies with FDA regulations.” However, in 2021, the European Food Safety Authority’s expert Panel on Food Additives and Flavourings found titanium dioxide is no longer considered food safe due to its potential to damage genetic material of cells and to cause respiratory issues. While many of the chemical additives mentioned in AB-418 are banned in other countries, the United States’ standards of food safety are clearly outdated and the new legislation is crucial to restrict the use of such dangerous toxins.

Many are concerned that this bill would outlaw these popular candies. However, in reality, it does not ban the products, but encourages ingredient changes for better overall safety. For instance, Canada, Europe, the U.K. and Brazil all have Skittles manufactured without titanium dioxide as it is only being used in small amounts to brighten the color of the candy. These additives are unnecessary to the flavor or consistency of the food, have no nutritional value and have equally effective alternatives. When given the choice between aesthetics and safety, it is obvious that these

candies ingredients should be changed.


Banning these toxic chemicals will establish new and improved industry standards for public safety. One of the largest opposers to the bill, the National Confectioners Association, claims that no reasonable evidence has been given to show that these additives are harmful. However, the NCA is also the largest U.S. trade association for confectioners, generating \$42 billion in sales per year and which Mars Incorporated is also a member of. Millions of

Americans, and not to mention their children,

continue to consume large amounts of harmful chemicals in candy, yet billion-dollar corporations are simply concerned with the loss of profit that comes with being labeled as “toxic.” The lack of appropriate food regulation perpetuates corporate power over American livelihood.

Outlawing these harmful additives will improve the safety of American products. Other countries have already banned these chemicals and the lack of similar laws in America only represents a gap in industry standards. Moreover, this

bill will not outright ban these iconic candies, but hold companies accountable for the products that they feed to the people. There is a blatant lack of consideration for American health in legislation, and it is essential that lawmakers begin prioritizing people’s wellbeing.


Immediate attention needs to be given to the Esports industry before it is too late

Painting over the legacy of Bob Ross, “Paint” continues to misuse the name of the greatest artist.

Bob Ross’ ’80s television show “The Joy of Painting” centered on his wholesome and heartfelt optimism as he taught viewers how to paint scenic landscapes, leaving a legacy of warmth and positivity that highlighted the natural beauty of our world. Nearly 30 years later, a new film with a questionably similar protagonist hits theaters. “Paint” follows Carl Nargle (Owen Wilson), a famous painter who ran Vermont’s top painting show. 

Carl goes through a primarily negative emotional arc and is characterized as both foolish and vain, something Bob Ross was not. Set in a tiny corner of



Compelling in its nostalgic aspects, the movie pays homage to easter eggs over the years ranging from the beloved Mario Kart map Rainbow Road to iconic variations of the Mario's theme song. Although staying safe within the realm of kids' films, the film falls just short of being perfect. Though the painstaking detail of the film illustrates the world in all its glory, too little screen time is used to build any character beyond their default facade. However, enough personality is present to entertain and allow audiences to fully waltz down memory lane with their favorite characters in excellent quality.
